AUTHORIZATION TO AWARD CONTRACTS FOR SUMMER PROJECTS**

WHEREAS, timely award of various contracts is required to permit critical summer work and,

WHEREAS, the current schedule of school board meetings will result in delays in awarding bids and,

WHEREAS, the completion of planned work is essential to fulfilling the commitments of Measure I, L, and H, Maintenance Assessment District (M.A.D), the Developer Fee, Beautification and Routine Restricted Maintenance Program, the completion of essential major maintenance projects, construction classrooms to house students, and the procurement of essential goods and services;

NOW, THEREFORE BE IT RESOLVED, that the Governing Board of the Hayward Unified School District delegates its authority to the Superintendent, the Assistant Superintendent of Business and/or his designee, to make such awards pursuant to Section 35161 and 17604 of the California Education Code; all transactions having complied with applicable procurement laws and processes. However, no contract made pursuant to the delegation and authorization shall be valid or constitute an enforceable obligation against the District unless and until the same shall have been approved or ratified by the governing board, the approval or ratification to be evidenced by a motion of the board duly passed and adopted.
